

PharmD Early Assurance Application PLANNING DOCUMENT - Fall 2026

Please use this planning document as a tool to help you prepare for the submission of your [official online application](#). You are advised to submit your online application in a single step, as some answers may be lost if you try to save and return to your application at a later time. Before starting your application, you should have the following items prepared:

- Electronic copies of your high school transcript, ACT/SAT scores, AP/IB transcripts, and college dual enrollment transcripts (if applicable).
- A resume that summarizes your work history, volunteer and leadership experience, skills, activities, and other achievements.
- Documentation of your fulfillment of the minimum math proficiency requirement.
- Prepared responses to both essay questions.
- Contact information for two individuals who have agreed to write letters of recommendation.

The Doctor of Pharmacy (PharmD) Early Assurance Application is available to students who have been admitted to the University of Arizona (UA) as degree-seeking first-time freshmen for the Fall 2026 semester. Students who are selected for this program receive provisional admission to the PharmD program for the Fall 2028 semester, pending successful completion of all prerequisite coursework and other admission conditions. Early Assurance students receive additional benefits, including mentoring and other opportunities to connect with the College of Pharmacy.

Admission to the Early Assurance program is selective. The following factors will be considered in the application review process:

- Math proficiency at the calculus level required, as demonstrated by a minimum SAT MATH score of 660 or ACT MATH score of 28, OR completion of a college calculus course (AP/IB or dual enrollment) OR score of 75 or higher on UA's PPL Math placement assessment. Documentation is required.
- 6th-semester core high school GPA of 3.5 or higher STRONGLY preferred.
- Submission of your high school transcript is required.
- Academic preparation, as demonstrated by high school record (especially science and math coursework), and general rigor of high school courses.
- Evidence of your passion and commitment to the field of pharmacy, as demonstrated by your essay responses.
- Evidence of your skills, character, determination, and fit with the field of pharmacy, as demonstrated by your letters of recommendation and resume.

Applications are considered on a rolling basis, so students are encouraged to apply early. The priority application deadline is April 15th, 2026. The final deadline is July 1st, 2026.

Students must meet a minimum math proficiency requirement in order to be considered for the Early Assurance program. Documentation of proficiency must be submitted at the time of application. Students have three options for meeting the math proficiency requirement. Please indicate which option applies to you:

- I have a minimum SAT MATH score of 660 or ACT MATH score of 28 that was earned on August 1, 2024 or later.
- I have already earned college credit for calculus, either through AP, IB, or dual enrollment. (In the case of dual enrollment, grade of A or B required.)
- I have taken the UA PPL math placement exam and earned a score of 75 or higher.
- I do not currently meet any of these criteria.*

* *The Early Assurance application is available only to students who can demonstrate math proficiency at the calculus level. If you do not currently meet this requirement but believe you could qualify via the UA PPL placement exam, you should contact Rebecca Field at rmitch@arizona.edu to discuss your next steps. You can restart your Early Assurance application once you have met the math requirement.*

Your reviewers may include teachers and other academic professionals, supervisors and professional colleagues, and mentors/advisors/coaches from clubs, teams, or organizations you have participated in or volunteered with. Family members and friends cannot serve as references.

Your reviewers are encouraged to address your skills, character, determination, and fit with the field of pharmacy when writing their letters of recommendation.

Please include any meaningful personal and/or academic experiences that have helped you determine your career goals. **You are encouraged to copy and paste your essay response into the application from a Word or text doc.*

Essay Prompt #2: In a maximum of 500 words, describe a non-academic area in which you excel. It could be an extracurricular activity, hobby, employment, volunteer experience, etc. Discuss the challenges you had to overcome in the process of attaining excellence and how you approached those challenges. Explain how the skills that you have learned from this non-academic activity will help you in your pharmacy career. Try to provide specific examples that connect your activity with excellence in the pharmacy profession. **You are encouraged to copy and paste your essay response into the application from a Word or text doc.*

Students who are selected for this program must be enrolled in the Pharmaceutical Sciences major, in the UA College of Pharmacy. If I am accepted to the Early Assurance program but Pharmaceutical Sciences is not currently my major, I agree to the major change.

I understand that the Early Assurance Program grants *provisional* admission to the PharmD program, contingent upon the following factors:

- Full-time undergraduate enrollment at the University of Arizona in the 2026 and 2027 academic years.
- Successful completion of all PharmD prerequisites by June 1st, 2028
- Adherence to Early Assurance GPA requirements
- Submission of PharmCAS application in the sophomore year
- Satisfactory performance in a PharmD interview in the sophomore year
- Completion of all PharmD admission requirements in place at the time of matriculation

Students who are not on track after their first year or who do not fulfill admission requirements within the two-year timeline will be able to apply for PharmD admission via the regular admissions pathway in a future year.
